TERMS & CONDITIONS

CHILDREN

Likuliku Lagoon Resort is an “adults only” resort and cannot accept reservations for guests under the age of 17 years.

CHECK IN / OUT TIME

Unless special prior arrangements have been made with the Resort, the official check-in time is strictly from **15:00 hours** local time on the day of arrival and check-out time from the Resort is by **11:00 hours** on the day of departure. Requests for extended check-out time, or early check-in will be based on availability and charges shall be negotiated individually with the Resort. **Please note:** early access to rooms cannot be guaranteed unless pre-registration is undertaken from the night prior.

PRICING

Accommodation rates are correct at the time of issue and are subject to change at any time in relation to implemented government taxes, levies, currency devaluations and fuel surcharges.

CANCELLATIONS & NO SHOWS

- All cancellations must be made in writing and confirmed by the resort.
- “No Shows” will be subject to room charges at the contract rate for all room nights booked.
- Any bookings cancelled between 8 and 21 days of travel will incur 75% cancellation fee.
- Bookings cancelled 7 days or less from the date of travel will be charged 100% cancellation fee.
- **Rooms cancelled within twenty-eight (28) days during peak season (1 April 2010 – 31 October 2010 and 20 December 2010 - 7 January 2011) will be charged a full cancellation fee for all room nights booked. This also includes bookings made and cancelled within this timeframe.**
- Guests who arrive late or depart early from the resort will be charged for the entire booking including unused accommodation.

PASSENGER RESPONSIBILITY

Please be advised that the Company will not accept any responsibility for any guests loss of or damage to personal equipment and property whilst staying at the Resort, or during participation in any activity. Guests are required to follow any directions which may be given whilst staying in the Resort or participating in activities.

The Company will not accept responsibility for any injuries which occur to guests whilst staying in the Resort or due to participation in any activity. Guests participating in scuba activities are requested to sign an Indemnity Release prior to instruction/diving.

FORCE MAJEURE

In the event that performance of this Agreement is delayed or prevented by any cause reasonably beyond the Resort's control, including, without limitations, any acts or orders of government authorities, or by fire, flood or explosion, sale of the Resort, necessary and essential construction, arrest or seizure and legal process, strike or other restraint of labour from whatever cause including flight delays, or act of terrorism, the Resort will be discharged of its obligation to provide accommodation or other services.

GOVERNING LAW

These terms and conditions are covered in all respects by the **LAW OF FIJI** and any legal action arising under the contract shall be litigated only in the appropriate court having jurisdiction in that country.

TRAVEL INSURANCE

We strongly recommend appropriate travel insurance coverage for all visitors to *Likuliku Lagoon Resort* to cover cancellation penalties levied as a result of inclement weather, airline or other transportation delays, other unforeseen disruptions, cancellations or delays or in the event of illness.
